



GUATEMALA CITY AIRPORT LA AURORA TRAVEL REQUIREMENTS

ARRIVALS

Passengers are not allowed to enter if in the past 14 days they have been to Brazil, South Africa or the United Kingdom.

2. Passengers must have a negative Antigen or negative Coronavirus (COVID-19) **PCR TEST RESULTS**, issued at most 3 days before departure from the first embarkation point.
3. Passengers with Covid vaccination certificate showing that they were fully vaccinated at least 2 weeks before departure.

This hospital has more requirements for the PCR

They require (and will issue if you don't have it,) the following:

-Ficha epidemiológica (no cost)

-Order médica (no cost)

Medical certificate Q250.00 (only if required by airline)

Results from 24 a 48 hrs.

All credit cards accepted or cash payments

For Centro Medico, the hospital prefers that the PCR test is done in the morning, with at least 2 hrs. after eating. They advise not to eat candies or chewing gum because it can affect the results. You can contact the Prevenga office, with Mrs. Melanie for the appointment.

IMPORTANT: Please check with your airline if a medical certificate is needed or if the PCR Test is sufficient for flying out.

Sanitary guidelines for the prevention of COVID-19 for travelers entering or leaving from international airports (AILA and MundoMaya)

(Sections 1 and 5 of the protocol are related to arrivals and departures.)

1. Prior to your trip, for GUA, arrivals or departures.

Responsible: Airline Operators

- a. Inform passengers about airport requirements.
- b. Required test: Negative PCR, test must be done with no more than 72 hours before (applies to travelers above 10 years old) for passengers entering the country.
- c. It is mandatory to use a mask for people over 2 years of age (The airlines must provide masks for those who do not wear them). Passengers with severe respiratory or cognitive difficulties who cannot tolerate them, are exempted from the use of masks.
- d. For passengers leaving the country, they must comply with the requirements of the destination country

5. Upon arrival, inside the GUA Airport

Responsible: Epidemiological Surveillance Unit (UVE) and Operations Center of Emergency (COE)

- a. Request negative PCR, with a maximum of 72 hours after the test has been done.
- b. For returned migrants, the procedures should be applied and are established in the corresponding protocol.
- c. Request public health information from all passengers.
- d. National passengers identified as suspected cases and their contacts must be transferred with the assistance of COE to the Isolation Center (cases) and quarantine (contacts).
- e. International passengers who developed symptoms during the flight are not allowed entry into the country.
